A RESOLUTION RECOMMENDING A FUNDING PRIORITY LIST FOR STATE-LOCAL INFRASTRUCTURE PARTNERSHIP ACT TO THE MONTANA DEPARTMENT OF COMMERCE

Whereas, H.B. 355 created "The State-Local Infrastructure Partnership Act of 2023" (Ch. 771, 2023) ("the Act");

Whereas, the Act created a state-funded program to fund the maintenance or repair of existing infrastructure on a partnership basis, with the city or town supplying a cash match;

Whereas, Section 5(2) of the Act requires the legislative body of the city or town to hold a public hearing and, based on the information received at the hearing, prepare and submit a recommendation for funding in priority order to the Montana Department of Commerce;

Whereas, a public hearing before the Town of Drummond was held on March 19, 2024 wherein the Town Council considered the proposed projects for Act funding.

Whereas, the Town of Drummond Town Council has identified the following infrastructure project(s) in priority order for Act funding; a copy of said infrastructure projects list is attached hereto as Exhibit A.

- 1. Repair Fire Suppression Water Line.
- 2. Street Maintenance and Improvements within Township.
- 3. Repair and Update Sidewalks.
- 4. Town Hall Building Improvement.
- 5. Add Radar Speed Sign.

Whereas, Notice of Public Comment and Hearing of House Bill 355 Town of Drummond Allocation was published twice on March 7, and 14, 2024 in the legal section of the Philipsburg Mail; a copy of said Legal Notice is attached hereto as Exhibit B.

Whereas, Town of Drummond received no submitted applications from the Townspeople of any suggested projects.

Whereas, this Resolution shall be submitted to the Montana Department of Commerce.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DRUMMOND, MONTANA, that the Town approves the fire suppression water line as priority when applying for House Bill 355 infrastructure funds allocated to the Town of Drummond, as evidenced by the Attached exhibits.
